PARCEL 1:

That part of the East 1/2 of Lot 4 of Block "II" of Vineland, according to the recorded plat thereof, in Asotin County, Washington, bounded on the North by a line parallel to and 530 feet distant southerly at right angles from the centerline of Chestnut Street, and bounded on the South by a line parallel to and 630 feet distant southerly at right angles from the centerline of Chestnut Street. EXCEPTING THEREFROM that portion lying within Francis Street and Birch Street.

PARCEL 2:

A part of Lot 4 in Block "II" of Vineland, Asotin County, Washington, according to the recorded plat thereof, particularly described as follows:

That part of the East half of lot 4 of said Block "II" of Vineland, bounded on the North by a line parallel to and 510 feet distant southerly at right angles from the centerline of Chestnut Street and bounded on the South by a line parallel to and 530 feet distant southerly at right angles from the centerline of Chestnut Street EXCEPT right of way for streets as now located.
