Introduction

This Voter Challenge Summary and accompanying Due Diligence materials are presented alongside the sworn Voter Challenge Form Affidavit and with reference to RCW 29A.08.810(1)(c)(ii)(A) – (E).

I personally have undertaken the research and compilation of the Due Diligence materials and have personal knowledge of each independent item of Due Diligence herein, having gained such knowledge by performing actions myself (e.g., preparing/mailling letters and querying online databases as required) and via others (e.g., tracking letters handled by USPS, contacting county staff regarding property ownership, obtaining canvasser/occupant affidavits).

This Challenge is not based upon unsupported allegations or allegations of anonymous third parties.

It is noted hearsay evidence is admissible in support of this Challenge. (Ref. RCW34.05).

Having exercised due diligence to personally verify the evidence presented on information and belief, following is the factual basis for the Challenge:

Background

Registrant JIL MARIE TAYLOR, YOB 1982, (the “REGISTRANT”) is registered with a residence address of 730 12th St., Clarkston WA 99403. There is a separate mailing address on file for the REGISTRANT in the Voter Registration Database (“VRDB”) of P.O. Box 31, Lewiston ID 83501.

The REGISTRANT appears to be registered to vote in Idaho and recently voted on 5 November 2024 in Idaho. The REGISTRANT last voted in Washington state in 2023.

Letter

On 3 September 2025, I mailed a letter via USPS Certified Mail to the registered address on file in the VRDB, notifying the REGISTRANT that the residence address listed in the VRDB is incorrect. The letter encouraged the REGISTRANT to cancel their registration and included an official Washington State form. A copy of the letter was mailed to the separate mailing address.

The US Postal Service forwarded the letter to Lewiston, Idaho, where the REGISTRANT picked it up in person at the US Postal facility. This requires presentation of identification, indicating the REGISTRANT is indeed physically located in Idaho and formally recovering mail forwarded from Washington state in Idaho.

An Asotin County Property Search conducted on 2 September 2025 shows that the property comprising the registered address is held in the name Jil Taylor.

I contacted the Nez Perce County (Idaho) Assessor's Office, who performed a formal property search at my request on 3 September 2025. No property deed returned in the name of Jil Taylor or Jil Marie or Jil Marie Taylor. No property deed returned in the name of anyone with the first name "Jil".

As of 1 August 2025, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Jil Marie Taylor with a birthyear of 1982 with a residence address of 730 12th St., Clarkston WA last voted on 25 April 2023.

The VoteRef website, containing the voter registration databases of at least 30 states, shows Jil Marie Taylor, with an age consistent with the REGISTRANT's age in the VRDB, registered to vote in Idaho on 13 June 2024 and voted in the 5 November 2024 general election in Idaho.

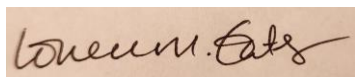
As of 1 September 2025, the Federal Bureau of Prisons Inmate Locator shows no federal incarceration for anyone named Jil Taylor.

The data indicates the registrant owns the property comprising the registered address however, she has instructed the US Postal Service to forward her mail to Lewiston, Idaho. She personally collected the certified letter sent in connection with this challenge. The data indicates the registrant does not have a landline phone number in Washington state and appears to be more recently registered to vote (and may be actively voting) in Idaho.

This registrant meets the requirements for a successful challenge under RCW 29A.08.810. It is therefore respectfully requested the registrant be canceled forthwith from the roll or the government show good cause in writing why the registrant may not be so canceled.
